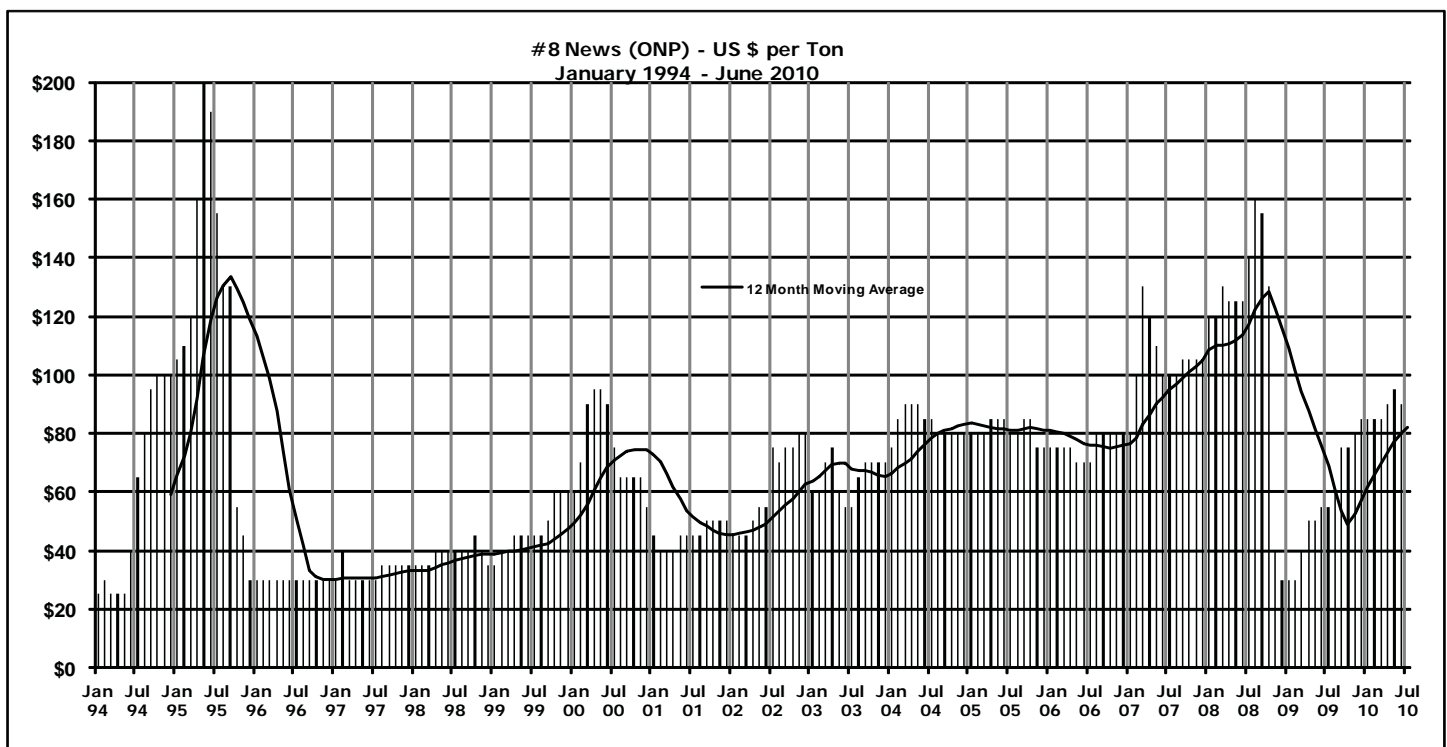
## RECYCLING MARKETS REPORT

We leverage our members' tonnage, seeking new markets to get YOU the best prices. How do our prices compare to what you are being offered?

With the exception of plastics, which have been bucking the trend, material prices have been declining for several months now and the word going around is that further price drops are ahead. Without firm signs of economic recovery manufacturers have been hesitant to increase production. These prices are still significantly ABOVE historical averages so declines would not be all that surprising.

All prices are net to you and subject to changing market conditions.

## Solid Waste Law Enacted in 2010 Session

The 2010 session of the Maine legislature was generally uneventful in regards to solid waste issues and resulted in only one law affecting solid waste being passed:

### **HP 1159, LD 1631 Summary**

LD 1631 authorized the Department of Environmental Protection to submit on an annual basis a report to the joint standing committee of the Legislature having jurisdiction over natural resources matters on products and product categories that when generated as waste may be appropriately managed under a product stewardship program. The bill authorized the joint standing committee of the Legislature having jurisdiction over natural resources matters to submit annually a bill to establish new product stewardship programs or revise existing product stewardship programs after the committee's review of the department report.
